# III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2022, item 574, i.e. Article 113 as amended) and who meet the following requirements:

- 1. Have completed studies in Polish philology, have a doctoral degree in literary studies,
- 2. Possess a proof of their academic, teaching and organisational achievements in research institutes and/or higher education,

3. Have a proof of their qualifications in the field of the history of Polish literature of the 20<sup>th</sup> and 21<sup>st</sup> centuries, confirmed by publications or other documented forms of scholarly activity; additional preference will be given to qualifications in the methodology of literary studies, translatology and comparative studies;

In justified cases, the committee reserves the right to request additional external reviews of the candidates' achievements and/or additional documents to further assess the candidates' qualifications.

# IV) Required languages

Native language – Polish, English – fluent.

# V) Required research, teaching or mixed experience

The competition is open to persons holding a master's degree in Polish philology, a doctoral degree in literary studies, specialising in the history of Polish literature of the 20<sup>th</sup> and 21<sup>st</sup> centuries, or in the methodology of literary studies, translatology or comparative studies. Research output and teaching experience will be assessed by the committee in proportion to the length of professional experience, thus levelling the playing field between candidates with a recent doctoral degree and those previously employed in academic positions. Any gaps in the academic curriculum vitae will not have a negative impact on the evaluation of the candidate.

# VII) Eligibility criteria

Research experience: number and quality of previous scientific publications and other scientific achievements (participation in national and international scientific conferences, grants, participation in research projects, internships, awards, etc.).

Teaching experience consistent with the teaching needs of the courses offered at the Faculty of Polish and Classical Philology. Organisational experience: organisation of scientific and popularisation events, working in scientific teams.

Planned activities in the field of internationalization of research (planned grant applications, research projects, publications in languages other than Polish).

English Certificate or a certification confirming teaching in this language.

#### VIII) The selection process

- 1. The commencement of the work of the Competition Committee Board no later than 14 days after the deadline of the submission of the documents by the candidates.
- 2. A formal assessment of the submitted applications.
- 3. In the event that any of the required documents shall be considered as missing, there will be a call for completion of the required documents or the candidate shall be asked to provide the additional documents.
- 4. The next stage being the selection of candidates for the interview.
- 5. Interview of selected candidates meeting formal requirements (maximum 5 persons).
- The Commission has the right to request external reviews of the candidates'
  achievements or to ask the candidates to conduct teaching activities with the
  possibility of their evaluation by students.
- 7. The chosen candidates invited to the interview may be asked by the Competition Committee to give a 15-minute speech on a scientific problem of their choice.
- 8. The results will be announced by the chair of the Competition Committee ommittee Board and the candidates will be informed of the outcome. The information will include a justification and an indication of the strengths and weaknesses of the candidates which took part in the competition. Supporting documents will also be sent to candidates.

# IX) Prospects for professional development

Thanks to winning the Competiton the Candidate will have the chance of working in one of the best Polish Studies Research and Teaching Centres and this is further seen the optimal way for a young researcher to best develop professionally. Assistant professors have regular contact with all of the research and teaching staff employed at the Faculty of Polish and Classical Philology at the University of Adam Mickiewicz, and participate in the scientific life of the Faculty, Institute and departments. He/she will have the opportunity to work in research teams and to consult the progress of his/her own research work during scientific meetings and conferences organised at the Institute of Polish Philology. He or she will receive support in the preparation and administrative handling of scientific grant applications, can apply for funding or co-financing of his or her own scientific publications and participation in national and international scientific conferences. He/she may also undertake research initiatives on his/her own and organise scientific conferences.

A newly recruited assistant professor may obtain a postdoctoral degree and become an independent researcher. Both teaching, research and organisational work at the Institute of Polish Philology at the University of Adam Mickiewicz makes it possible to broaden the scientific output, gain the necessary competence, experience and authority to apply for this degree. The habilitation procedure is entirely financed by the Faculty of Polish and Classical Philology at the University of Adam Mickiewicz.
