## II) Job Offer description

Employment in a postdoctoral position at the Jesuit Studies Laboratory, directed by Prof. Dr. Robert A. Maryks

### 1. Post-doc 1 - Early Modern Intelligence and Political Networks

### Tasks:

- Conduct deep archival research across multiple European repositories.
- Collect, transcribe, and analyze primary sources, including letters, reports, and state documents.
- Reconstruct strategies, motivations, and structures underlying Sarpi's clandestine network.
- Collaborate closely with literary and digital humanities teams to inform the project's analytical frameworks.

## 2. Post-doc 2 – Rhetoric, Subversion, and Conspiratorial Literature

### Tasks:

- Conduct close readings and contextual literary analyses to examine texts as tools of resistance.
- Analyze how conspiratorial and subversive literature shapes public perception and undermines ecclesiastical and political authority.
- Collaborate with the digital humanities team to apply computational tools, including the Grammar of Conspiracy Matrix Analysis (GCMA), to detect rhetorical patterns across the corpus.

### III) Requirments and qualifications

The competition is open to individuals who meet the requirements specified in Article 113 of the Law on Higher Education and Science of 20 July 2018 (Journal of Laws of 2024, item 1571, Article 113 as amended) and who meet the following requirements:

- obtained a doctoral degree in an entity other than the entity where employment in this
  position is planned, or completed at least 10-month, continuous and documented
  postdoctoral internship in an entity other than the entity implementing the project and in a
  country other than the country of obtaining the doctoral degree;
- during the period of receiving this remuneration, candidates will not receive remuneration from another employer under an employment contract, including from an employer based outside Poland.
- obtained a doctoral degree in the year of employment in the project or in the period of 12 years before January 1 of the year of employment in the project. This period may be extended by the time spent on long-term (over 90 days) documented sickness benefits or rehabilitation benefits due to incapacity for work. Additionally, this period may be extended by the number of months spent on leave related to the care and upbringing of children granted under the terms set out in

the Labor Code, and in the case of women - by 18 months for each born or adopted child, if this method of indicating breaks in a scientific career is more favorable.

- 2. Formal evaluation of submitted proposals.

- 4. Selection of candidates for the interview stage.

- 5. Interviews for candidates who meet the formal requirements.
- 6. The chair of the competition committee announces the results and informs the candidates. This information will include justification with a reference to candidates' strengths and weaknesses.
